ALL TO ORDER:

President Ochs opened the Tremont Borough Council Meeting with the Pledge of Allegiance. The meeting was called to order at 6:32 p.m. at the Tremont Borough Building.

APPROVAL OF MINUTES:

 Motion made by Scheibley, second by Eisenacher, approving the March 11, 2025 Regular Meeting Minutes. All in favor; Minutes approved.

SOLICITOR'S REPORT:

Attorney Shane Hobbs

- No parking on Pine Street (Dayton Superior side)
 - Clarification from last month's meeting: Scheibley is requesting for no parking from Cherry Alley to Spring and from Reservoir Road to Church Street on Pine Street. The block with Dayton Superior is not included.
 - Motion made by Scheibley, second by Ochs, amending the original Motion made on February 11, 2025, by allowing the Streets Department to extend the no parking areas on Pine Street, on the blocks of Cherry Alley to Spring and from Reservoir Road to Church Street by painting the curbs back further, therefore no Resolution nor No Parking Signs are needed. All in favor; Motion passed.
- Problem Properties
 - Hobbs needed some clarification on some of these properties because it wasn't clear on the Parcel Locator because they were double dwellings.
 - 29 Spring Street
 - There is a hearing date pending.
 - 312 and 314 E. Main Street (Fire Properties)
 - Hobbs sent letters but received no response.
 - Neighbor is not interested in buying properties due to the costs associated with them.

MAYOR'S REPORT:

Mayor Gerald Fasnacht:

- The list of Water Shut-offs is multiple pages long. He is questioning why Marty isn't doing anything with these properties.
- A complaint was received for 110 W. Main Street, the garage is falling down. The owners haven't been there in over a year.
 - Scheibley voiced his opinion about the Code Enforcement and Property Maintenance Officer not following up
 on any of the burned properties or the vehicles that were tagged. Scheibley feels the Borough needs a Code
 Enforcement Officer that is available to come out when we call.
 - Eisenacher recommends contacting Keith Heigel about their concerns with Marty Sowers.
 - Council instructed the Secretary to email Keith Heigel.

PUBLIC UTILITY AND STREETS:

- We received the Title for Yamaha Rhino ATV
- Scheibley reported that the County Bridge Construction Project will begin any day
 - Scheibley contacted the company about the detour sign issues.
 - They put them in yards without the owner's permission. There are also issues with the signs by the railroad tracks.
 - They are also sending all traffic down Pine Street.

- They have to get any detour changes approved, so it will continue on Pine Street until they get the approval.
- Scheibley expressed his concerns with the intersection by the Corner Bar, you can't see to pull out now and he feels that is only going to get worse when Randazzo's opens, with people pulling in to pick up their food.
 - Council recommends putting mirrors up to see oncoming traffic.
- President Ochs questioned Scheibley about the top seal maintenance and upkeep of the Union Street Bridge.
 - Scheibley is going to ask New Enterprise to do it when they come in to do Union Street.

PROPERTY:

- Updates on burned properties were discussed at the beginning of the meeting.
- Yard Waste & Ash Pick up will only be on Mondays starting April 14th. Scheibley reminded residents that the yard waste must be bagged and bags can be too heavy to lift onto the truck. Call him or the office to let us know you are putting it out.

PUBLIC HEALTH AND SAFETY:

Fire Chief's Report

- Fire Chief Eisenacher reported they had 20 calls in March 2025, which included Immediate Response Team in Walker Township.
- Chief Eisenacher will be on vacation from the 16th through the 27th

SCMA Tremont Water Source of Supply History

Borough of Tremont operated off Tierney Reservoir only, chlorine disinfection, gravity to town, no fire protection or storage, water quality issues, drought issues

1996 SCMA constructed Tremont Water Filtration Plant, 1.0 MG Storage Tank, developed Well #4 and Well #2, 12" main to town, pressure regulating stations, 12" main to Donaldson.

- Well #4 permitted/rated at 331,000 gpd
- Well #2 permitted/rated at 331,000 gpd

1998 Drought; experienced lack of water supply, had to temporarily haul water from another SCMA source; cost over \$100,000 for approximately 1 month

2001 SCMA constructed Well #15 (near Tierney Reservoir), booster station and raw waterline to plant

Well #15 rated at 187,000 gpd

2024 Drought; experienced lack of water supply.

• Major fire in Tremont; used approximately 600,000 gallons in less than 24-hours SCMA began hauling operations to supplement supply and keep adequate fire protection in tank. To date, hauled 516 trucks, or 3,322,274 gallons water at cost of \$420,188.00, not including additional labor, overtime, and miscellaneous parts costs.

2022 SCMA was awarded an Appalachian Regional Commission (ARC) and DCED grant to perform water feasibility study. Report complete. Currently pursuing additional grant funding for construction related activities.

Presently under design for permanent PADEP permitting to utilize raw water from Tierney Reservoir and pump it to WTP via Well #15 booster station.

Begun hydrogeologic study for additional well supplies in regional area.

Current usage data:

- 2024 average daily production: 222,490 gpd
- Additional commercial and regional connections:
 - o Big Lots 7,355 gpd
 - o Amazon 5,436 gpd
 - o Reilly Twp/Newtown 9,460 gpd

Capital Improvement Fees: In 2023, SCMA passed Resolution Nos. 07-19-23-1/2, which assess Capital Improvement Fees for both water and sewer in the Tremont District for any proposed commercial and industrial development that requires additional water and/or sewer capacity requirements. Funds are earmarked for upgrades to both water and sewer systems. Both Panattoni Buildings (Amazon and Bldg #2) were assessed Capital Improvement Fees.
