

**TREMONT BOROUGH COUNCIL**  
**MEETING MINUTES**  
**July 8, 2025**

**ALL TO ORDER:**

President Ochs opened the Tremont Borough Council Meeting with the Pledge of Allegiance. The meeting was called to order at 6:35 p.m. at the Tremont Borough Building.

**APPROVAL OF MINUTES:**

- Motion made by Adams, second by Ochs, approving the June 10, 2025 Regular Meeting Minutes. All in favor; Minutes approved.

**SOLICITOR'S REPORT:**

- Problem Properties
  - 29 Spring Street
    - Order of Court to bring the property in compliance within 30 days
    - Marty will post property
      - Neighbors still see people coming in and out of the house
  - 314 / 312 E. Main Street
    - Realtor wants to rehab and sell it
    - Escrow check is being re-issued
      - Mayor: Property can't be sold until it passes Code or until both parties sign in front of District Justice for the new owner to bring it up to code.
- Motion made by Strickler, second by Adams to advertise the Nuisance Fire Alarm Ordinance after Solicitor and Secretary review. All in favor; Motion passed.

**MAYOR'S REPORT:**

*Mayor Gerald Fasnacht:*

- The Mayor asked about his request to add on to QOL tickets. Secretary will look up what they were specifically.
- He can't tow vehicles because he isn't the Code Officer. You need to have an official badge number.
- He is getting a lot of grass complaints. He feels like it is a double-edged sword to bring Marty in for this.

- 120 W. Main (Funeral Home) – I looked at this. The downspout is discharging directly onto the public sidewalk. Does the borough have an ordinance explicitly prohibiting downspouts to discharge onto public sidewalk. This is a typical occurrence. If the borough.

***RECREATION & EDUCATION:***

- The Secretary read the report submitted by John Poff for the Playground Project:
- ***Tremont Park Playground Project (DCNR Grant):***
  - Arthur "Pat" Aungst & Sons has ordered the playground equipment and will mobilize approximately two to three weeks prior to the playground equipment delivery. I am anticipating work starting around the beginning of September. Note, there is a long lead time on the pavilion. Based on the late equipment deliveries, the Borough will probably have to give the Contractor a time extension till the end of the year.

- **Stormwater Collection System Project (DCED Grant):**

LHAI has started preliminary engineering work on the project.

- Scheibley is in contact with PPL to get the pole moved
- President Ochs thinks there should be electricity in the pavilion

- The people interested in starting a Pool Committee addressed Council:

- Their Treasurer, Paulette Yuschock quit, Emily Fisher will replace her.
- They had questions about the Pool Bank Account, the Pool Electric, the Feasibility Study, which got out of line so the Mayor stopped it and ejected Laurie Bender, a representative for the Pool Committee, from the meeting. Solicitor Hobbs recommended that they submit a right-to-know request.

- Community Yard Sale will be Saturday, September 6, 2025 from 8 am – 2 pm.


**CITIZEN COMMUNICATION:**
